Sub: Extension of Provisional Affiliation to the above said school beyond 31.03.2017 - reg.

Sr/Madam,

This is with reference to your online application dated 30/06/2016 on the subject cited above.

In this connection, I am directed to convey sanction of extension of provisional affiliation of the school with the Board for its **Secondary School Examination and Senior Secondary School Examination** for a further period of **Five years w.e.f. 01.04.2017 to 31.03.2022** subject to the fulfillment of the following conditions in addition to the general conditions intimated at the time of grant of provisional affiliation for secondary classes and senior secondary classes:-

1. The School is required to follow syllabi and course as per scheme of studies prescribed by the Board for the respective Examination.
2. The School is required to abide itself by the Examination/Affiliation-Bye-Laws of the Board.
3. The School is required to apply on online for further extension of affiliation alongwith the requisite fee and other documents by 30th June of the preceding year in which the Provisional Affiliation expires. Applications will be accepted after the last date along with the prescribed fee and late fee Rs. 10,000/- per month subject to maximum of Rs. 50,000/-.
4. Provisional Affiliation granted to a school will remain valid on receipt of online application of a school for further extension of provisional affiliation subject to the final decision of the Board.(Amended Rule 15.11).
5. It is mandatory for every affiliated school to become a member in the local Sahodaya of CBSE schools.
6. The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation Bye-Laws of the Board which shall not in general exceed the optimum number as under from Pre-Primary to Class XII :-

(a)	1.0 acre	1250	02 in each class	04 in class XI and XII
(b)	1.5 acre	1875	03 in each class	04 in class XI and XII

(d) School running on bigger campus of more than 02 acres, the number of students shall be restricted as per the actual facilities in the school which shall be proportionate to the optimum number mentioned at (a), (b) and (c) above.

(e) Schools running on less than 01 acre campus shall restrict number of students as follow:-

(i) Secondary School	2000 sq. mtrs	600 upto Class X
(ii) Sr. Secondary School with two streams	3000 sq. mtrs	900 upto Class XII

7. The school will strictly adhere with all rules regarding safety of students including Fire fighting, Drinking water, Sanitation, Transportation, etc.
8. Income & Expenditure and audited annual accounts statement duly certified by the Chartered Accountant for the current year is required to be sent and the same be submitted every year.
9. **Other conditions are enclosed as per Annexure 'A'.**
10. **Special conditions to be complied within three months:-**

- (a) The school is required to maintain FDR of reserve fund in the joint names of the Manager of the school and the Secretary, CBSE of the Board according to the strength of the students/norms of the Affiliation Bye-Laws of the Board and submit a copy of the same.
- (b) The school is required to submit copies of renewed certificates of fire safety, building safety, Health-Sanitation Certificate and safe drinking water issued from concerned/competent authority of the State Government.
- (c) Number of books in the library is not as per Affiliation Bye-laws. Therefore, the school is required to procure more books relevant to improve the academic level of students in the library and keep at least 05 books per student in the library excluding text books, magazines etc. (intimate total books in the library).
- (d) The school is required to appoint more trained and qualified 06 TGTs to maintain section-teacher ratio as per norms and furnish a fresh staff statement accordingly.

***The Extension of Provisional Affiliation up to Senior Secondary level w.e.f. 01/04/2017 to 31/03/2022 has been granted provisionally subject to the conditions that the school will pay the pay scale and allowances which should at least be at par with corresponding categories of teachers employed in government institutions of the State Govt. or as per scale prescribed in 6th Central Pay Commission of Govt. of India in respect of its teachers and will make the payment through ECS mode with proper deduction of EPF and other facilities as per norms of the Board. Besides, the school should have qualified and trained teaching staff. The same can be checked and verified by the Board at any time.
